


QuickStart Guide for:

Academic Search Premier

Directions:

Academic Search Premier allows you to search for articles in periodicals that are either academic (peer-reviewed) or trade-related in nature.



This is a screen shot of Academic Search Premier after a keyword search (“global” and “warming”) has been entered. Articles 1 and 2 were retrieved because they contain the keyword words “global” and/or “warming”.

The “All Results” (at the top of the image) shows that 16,436 results were found. You can “Narrow Results by” selecting the links on the left of the image or changing your search phrase. See the *Booleans* under the help function of the database for search strategies.

Definitions:

Peer Reviewed: Peer-reviewed articles are typically written by academic experts (professors) with advanced degrees in their respective fields. In order to be published in academic journals, these articles are submitted through a rigorous process of review by other academic experts who determine if the article is appropriate for publication in the journal.

Periodical: Publications that are published periodically (weekly, monthly, biannually, annually, etc.) Some examples include: *New York Times*, *Time Magazine*, *the Economist*, and *Forbes*. Some are scholarly, or peer-reviewed, in nature. Some examples include: *American Literature*, *Aboriginal History*, *Academic Radiology*.

Trade Periodicals: Trade periodicals are not academic in nature but are written for an audience interested in a particular trade, such as business

The page gives the **Title** again. The **Authors** (Simoes and La Rovere) are provided. The **Source** provides the name of the publication that the article is in. In this case it is a periodical titled *Energy Sources Part A*. Additionally, the **Source** gives the publication date and page numbers.

Things to Remember:

Limit your search to retrieve only *full-text* articles by selecting the *full-text box* at the top of the results page (The page that lists the articles after you have entered the keyword into the search box on the main page.) You can see this option on the *Advanced Search* page, which can be accessed from the database’s homepage.

Academic Search Premier gives you the option of printing, saving, or emailing the article.
